ARTICLE 19, an international organisation that works to defend and promote freedom of expression and access to information, is launching a new campaign on disinformation here in Ireland. By reference to the <u>Joint</u> <u>Declaration on Freedom of Expression and "Fake News", Disinformation</u> <u>and Propaganda</u>, disinformation - also referred to as "false" or "fake news" - is "often designed and implemented so as to mislead a population, as well as to interfere with the public's right to know and the right of individuals to seek and receive, as well as to impart, information and ideas of all kinds, regardless of frontiers, protected under international legal guarantees of the rights to freedom of expression and to hold opinions". In recent months, the challenges posed by disinformation to freedom of expression and other human rights were widely discussed in the context of COVID-19 in Ireland and across the world.

As a campaign ambassador, you'll explore the connections between disinformation and freedom of expression. You will participate in the vibrant debate that's taking place in Ireland right now on how to combat disinformation, ensure online safety - and protect the right to freedom of expression in Ireland.



We'll need you to:

- Be aged 18-25
- Be passionate about freedom of expression
- Bring your voice to the campaign
- Complete campaign surveys
- Participate in a few orientation sessions (Nov 2020)
- Participate in a youth-led debate on disinformation (Mar 2021)
- Have your voice heard in important discussions on disinformation, freedom of expression and related topics
- Act as an ambassador for the duration of the campaign (Nov 2020 Mar 2021)

 - Among your friends, family and networks
